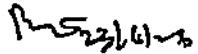

**CORRIGENDUM**  
**ONLINE COOPERATIVE QUIZ COMPETITION – 2026**

In continuation of the Public Notice/Circular dated 22.06.2026 regarding the Online Cooperative Quiz Competition – 2026 issued by this office, the following clarifications/modifications are hereby notified for information of all concerned:

1. **Mode of Registration:** Registration for the Online Cooperative Quiz Competition shall be made only through the e-Forms Registration Link to be hosted on the official website of the Office of the Registrar Cooperative Societies, GNCT of Delhi.
2. **Single Registration:** Each participant shall be permitted to register only once. Multiple registrations by the same participant shall render the candidature liable to rejection/disqualification.
3. **Number of Questions:** The Online Quiz shall consist of 100 Multiple Choice Questions (MCQs) carrying one mark each.
4. **Access to Online Quiz:** After successful registration, each participant shall be provided a unique access link through e-Forms on the registered email address. Participants shall submit their answers to the MCQs through the said e-Forms link only. The access link shall be personal and non-transferable.
5. **Purpose of Online Quiz:** The Online Quiz shall serve as a screening/scrutiny round for short listing participants for the Final Round. Participants securing the highest scores shall be shortlisted for participation in the Final Round in accordance with the prescribed guidelines.
6. **Grievance Redressal:** Any participant aggrieved by the result of the Online Quiz may submit a grievance through email at [rcoop@nic.in](mailto:rcoop@nic.in) within seven (7) days from the date of publication of results. Grievances received after the prescribed period shall not ordinarily be entertained.
7. **Other Terms and Conditions:** All other terms and conditions contained in the Public Notice/Circular and Guidelines for Online Cooperative Quiz Competition – 2026 shall remain unchanged and continue to apply.

**GUIDELINES FOR ONLINE COOPERATIVE QUIZ COMPETITION – 2026**  
*(To be held during Cooperative Week from 29 June 2026 to 06 July 2026)*

**1. SHORT TITLE AND OBJECTIVE**

**1.1 Short Title**

These Guidelines may be called the "Guidelines for Online Cooperative Quiz Competition – 2026".

**1.2 Objective**

The Online Cooperative Quiz Competition is being organized by the Office of the Registrar Cooperative Societies, Government of NCT of Delhi during Cooperative Week – 2026 with the objectives of:

- a) Promoting awareness regarding the Cooperative Movement;
- b) Disseminating knowledge about Cooperative Principles, Values and Governance;
- c) Enhancing understanding of cooperative laws, policies and government initiatives relating to the cooperative sector;
- d) Encouraging participation of citizens, students, members of cooperative societies and stakeholders in cooperative activities; and
- e) Promoting cooperative education and public awareness.

**2. ORGANIZING AUTHORITY**

The Competition shall be organized by the Office of the Registrar Cooperative Societies, Government of NCT of Delhi (RCS Office).

The decision of the Registrar Cooperative Societies, the Quiz Committee or any authority constituted for conduct of the Competition shall be final and binding upon all participants.

**3. ELIGIBILITY**

**3.1 Eligible Participants**

The Competition shall be open to all citizens ordinarily residing in the National Capital Territory of Delhi.

**3.2 Ineligible Persons**

The following persons shall not be eligible:

- a) Members of the Quiz Committee, Jury or Evaluation Committee;
- b) Officers/officials directly associated with preparation of question bank, moderation, evaluation or conduct of the Competition;
- c) Immediate family members of persons mentioned above;
- d) Persons furnishing false, misleading or fabricated information during registration or verification.

**4. REGISTRATION**



#### **4.1 Mode of Registration**

Registration shall be conducted only through the e-Forms Registration Link hosted on the official website of the Office of the Registrar Cooperative Societies, GNCT of Delhi. No other mode of registration shall be accepted.

#### **4.2 Information Required**

Participants shall furnish the following information:

- a) Full Name;
- b) Date of Birth;
- c) Mobile Number;
- d) Email Address;
- e) Residential Address;
- f) Aadhaar Number (last four digits only, if required);
- g) Educational Qualification (optional);
- h) Occupation (optional); and
- i) Any other information considered necessary by the Organizing Authority.

#### **4.3 Verification Documents**

Participants may upload one or more of the following documents:

- Aadhaar Card;
- Voter Identity Card;
- Driving Licence;
- Passport;
- Educational Institution Identity Card;
- Employment Certificate;
- Utility Bill; or
- Any other document accepted by the Organizing Authority.

#### **4.4 Acceptance of Registration**

Registration shall be deemed provisional until verification by the Organizing Authority. The Organizing Authority reserves the right to reject any registration where eligibility conditions are not fulfilled or where information furnished is found to be incorrect.

#### **4.5 Single Registration**

Each participant shall be permitted to register only once. Multiple registrations by the same participant shall render the candidature liable to rejection or disqualification at any stage of the Competition.

#### **4.6 Registration Instructions**

Detailed instructions regarding registration, access links and participation shall be communicated through the Department's website.

- Delhi Cooperative Societies Act, 2003;
- Delhi Cooperative Societies Rules, 2007;
- Relevant notifications, circulars and policy directions.

## **5.5 Government Initiatives**

- National Cooperative Policy;
- Ministry of Cooperation initiatives;
- Cooperative reforms;
- Digitization of cooperatives.

## **5.6 Allied Areas**

- Agricultural Cooperatives;
- Dairy Cooperatives;
- Housing Cooperatives;
- Consumer Cooperatives;
- Credit Cooperatives;
- International Cooperative Institutions.

# **6. ONLINE QUIZ**

## **6.1 Format**

| Particular | Details                          |

| Duration   | 20 Minutes                       |

## **6.2 Number of Questions**

The Online Quiz shall consist of **100 Multiple Choice Questions (MCQs)** carrying one mark each.

## **6.3 Language**

The Quiz may be conducted in Hindi, English or bilingually, as decided by the Organizing Authority.

## **6.4 Access to Online Quiz**

After successful registration, each participant shall be provided a unique access link through e-Forms on the registered email address. Participants shall submit their answers only through the said e-Forms link. The access link shall be personal and non-transferable.

## **6.5 Technical Requirements**

Participants shall ensure availability of:

- Internet connectivity;
- Suitable device (computer, laptop, tablet or smartphone);
- Functional email account.

## **7. SCORING PATTERN**

### **7.1 Marking Scheme**

| Response         | Marks |
|------------------|-------|
| Correct Answer   | +1    |
| Incorrect Answer | 0     |
| Unanswered       | 0     |

### **7.2 Negative Marking**

There shall be no negative marking.

### **7.3 Ranking**

Participants shall be ranked according to total marks obtained.

## **8. SHORTLISTING FOR FINAL ROUND**

### **8.1 Number of Participants**

The top twenty (20) participants or such number as approved by the Competent Authority shall be shortlisted for the Final Round.

### **8.2 Verification**

Shortlisted participants shall undergo verification of identity and residence.

### **8.3 Failure to Verify**

Failure to produce original documents, if required, may result in cancellation of candidature.

## **9. FINAL ROUND**

### **9.1 Mode**

The Final Round shall be conducted physically at a venue notified by the Department.

### **9.2 Format**

The Final Round may include:

- Rapid Fire Round;
- Buzzer Round;
- Audio-Visual Round;
- Situation-Based Round;
- Any other format approved by the Quiz Committee.

### **9.3 Determination of Winners**

Final rankings shall be determined solely on the basis of performance in the Final Round.



Scores of the Online Quiz shall ordinarily not be carried forward unless otherwise notified.

## **10. PRIZES**

The following cash prizes shall be awarded:

| Position     | Prize Amount |

The Competent Authority reserves the right to modify, enhance or withdraw prizes.

## **11. CERTIFICATES**

### **11.1 Participation Certificates**

Digital Participation Certificates may be issued to participants who successfully complete the Online Quiz.

### **11.2 Merit Certificates**

Certificates of Merit may be awarded to shortlisted participants and winners.

## **12. UNFAIR MEANS AND DISQUALIFICATION**

A participant shall be liable for disqualification if he/she:

- a) Furnishes false information;
- b) Uses multiple registrations;
- c) Uses another person's identity;
- d) Shares access credentials;
- e) Uses bots, automated tools or unauthorized assistance;
- f) Attempts to manipulate or interfere with the online platform;
- g) Indulges in misconduct during the Competition;
- h) Violates these Guidelines;
- i) Creates more than one registration or account for participation.

The Organizing Authority may cancel candidature at any stage without prior notice.

## **13. QUIZ COMMITTEE**

The Registrar Cooperative Societies may constitute a Quiz Committee comprising:

3. Assistant Director (IT)

### **Member Secretary**

- Section Officer (Policy)



#### **14. FUNCTIONS OF QUIZ COMMITTEE**

The Committee shall:

- a) Approve syllabus and content;
- b) Supervise conduct of the Competition;
- c) Verify shortlisted participants;
- d) Examine grievances and complaints;
- e) Recommend declaration of results;
- f) Perform any other function necessary for successful conduct of the Competition.

#### **15. CONFIDENTIALITY**

The question bank, answer keys, evaluation process and related records shall remain confidential until declaration of results.

All officials associated with the Competition shall maintain strict confidentiality.

#### **16. DECLARATION OF RESULTS**

##### **16.1 Online Quiz**

The Online Quiz shall serve only as a screening/scrutiny round for shortlisting participants for the Final Round. Participants securing the highest scores shall be shortlisted in accordance with these Guidelines. The list of shortlisted participants shall be published on the Department's website.

##### **16.2 Final Round**

The Final Round shall be conducted physically at the venue notified by the Department. The final results shall be declared during the closing ceremony of Cooperative Week or on such date and at such place as may be notified by the Organizing Authority. Participation in the Final Round shall be at the participant's own cost. No Travelling Allowance (TA), Daily Allowance (DA), boarding, lodging or any other expenditure shall be admissible or reimbursable by the Department for attending the Final Round or for receiving prizes/certificates.

##### **16.3 Publication**

The Department may publish the names, photographs and achievements of winners on its website and publicity material.

#### **17. GRIEVANCE REDRESSAL MECHANISM**

##### **17.1 Submission of Grievances**

Any participant aggrieved by the result of the Online Quiz may submit a grievance through email at [rcoop@nic.in](mailto:rcoop@nic.in) within seven (7) days from publication of results.

##### **17.2 Examination**

The grievance shall be examined by the Quiz Committee.

##### **17.3 Disposal**

The decision of the Quiz Committee, approved by the Registrar Cooperative Societies, shall be final and binding.

Grievances received after the prescribed period shall not ordinarily be entertained.



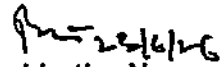
#### **18. DISCLAIMER**
