ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, Eklavya CGHS Ltd., Plot No. 18/1, Sector-13, Rohini, Delhi-110085, is registered vide Registration No. 564/GH with this Department under the provisions of the DCS Act, 2003, the Rules framed there under, and the Bye-laws of the Society.

And whereas, Sh. Deepak Bhardwaj, Section Officer, was appointed as Administrator-cum-R.O. of the aforesaid Society vide this office Order dated 18.02.2026, and his initial tenure expired on 18.05.2026 and whereas the Competent Authority regularized his tenure for a further period from 19.05.2025 to 03.08.2026.

And whereas, the Registrar, Cooperative Societies has considered the matter and approved for the appointment of Sh. Mahesh Chandra Jha, Retd. Joint Director Railway Board, New Delhi, as Administrator-cum-Returning Officer under Section 35(5) of DCS Act, 2003 in Eklavya CGHS Ltd. with immediate effect. The Administrator so appointed shall conduct the election of the Managing Committee within a stipulated period of ninety (90) days from the date of his appointment. He shall be paid remuneration of ₹10,000/- (Rupees Ten Thousand Only) per month plus applicable Travelling Allowance, to be borne from the funds of the Society. And he will be also submitting monthly progress report about the status of affairs of the society by 10th of every month.

Further, Sh. Deepak Bhardwaj, Section Officer the then Administrator, is hereby directed to hand over the charge of all relevant records and documents of the Society to Sh. Mahesh Chandra Jha immediately, under intimation to this office.
