**Subject : Annual Report of the ministry of Home Affairs for the year 2020-21**

This office is functioning under the provision of DCS Act 2003 and DCS Rules 2007. The Registrar Co-operative Societies appointed by the Government, heads the cooperative Department and plays a pivotal role in monitoring the functioning of Cooperative Societies registered under the Act. The Lt. Governor also appoints other persons to assist the Registrar and has designated them as joint Registrar, Deputy Registrar, Assistant Registrar. The Main functions of this office are to conduct the Election of Cooperative Societies, Clearance of Membership of CGHS under Rule 90, Regularisation of self-draw, Settlement of disputes u/s 70 etc.

**Recovery**

Outstanding dues of Co-operative Societies (recoverable as arrears of land revenue) recovered by the department during this year from 01/04/2020 to 30/11/2020 is Rs. 7.67 crore and 1.15 crore has been deposited in Coop Education fund by profit making Cooperative Societies.

**Settlement of Arbitration Cases**

234 Officers (serving/ retired) have been empanelled to work as Arbitrator to resolve the dispute of cooperative societies U/s 71 of DCS Act 2003. The arbitration proceedings are conducted under Section 70/71 of DCS Act 2003. The department has settled a total of 1210 cases from 01.04.2020 to 31.12.2020 and a total of 1924 cases have been admitted for approval during the period 01.04.2020 to 31.12.2020 and are under process.

**Budget Allocation/Expenditure**

The Budget allocation in Capital and Revenue of Department of Cooperative Societies for year 2020-21 is Rs. 30 lakhs and Rs.1539.00 lakhs and the expenditure incurred is Rs.22.19 lakhs and Rs.1068.42 lakhs respectively upto the month of the December 2020.

**Clearance of Membership under Rule 90**

The RCS office has cleared 97 cases under Rule 90 of various Societies w.e.f. 01-04-2020 to Nov. 2020.

This office has settled 11 appeals for grant of Membership under section 91 of DCS Act 2003 w.e.f. 01/04/2020 to November 2020.

487 grievances out of 564 under PGMS,L.G. Listening post and CPGRAMS have also been replied.
