ORDER

Whereas, The NTPC EMPLOYEES CGHS LTD. plot No.10, Sector-19B, Dwarka, New Delhi-110075 is registered with this department vide Regn. No.1163 GH under the provisions of DCS Act/Rules/Bye-Laws of the society; and

Whereas, the Delhi Cooperative Societies Act, 2003 has come into force w.e.f 01.4.2005 vide notification dated 24.03.2005. As per the provision of Section 35(1) of DCS Act, 2003 the election of the Managing Committee of the society shall be held by Returning Officer not below the rank of Gazetted Officer;

Whereas, the Competent Authority in exercise of powers vested in her under Section 35 of DCS Act, 2003, has approved appointment of Sh. T.Tarun Kumar, Assistant Director (Planning), O/o RCS, Parliament Street, New Delhi as Returning Officer on the request of Executive Members of present Managing Committee who already tendered their resignation and other members of society with due diligence for holding the election of the new Managing Committee of the aforesaid society as per DCS Act & Rules within 60 days from the date of issue of this order. The expenses of holding the election will be met out from the funds of the society.

Now, therefore, the society is directed to furnish the relevant documents/papers to the Returning Officer within 7 days from the issue of this order. Sh. T. Tarun Kumar, Assistant Director (Planning), O/o RCS, New Delhi will be paid Rs. 6000/- as remuneration for conducting election by the society itself.
