Whereas, United CGHS Ltd., Plot No.34, Sec-4, Dwarka, New Delhi-110078 is registered vide registration No.817 (GH) under the provisions of DCS Act/Rules and Bye-Laws of the society.

Krishan Lal, Dy. Secretary, GAD as Returning Officer in the Society with the direction to hold the election to the Managing Committee of aforesaid society within 90 days of receipt of this order. The Administrator will be paid a honorarium Rs.10000/- per month from the society's fund and Returning Officer a consolidated honorarium of Rs.6000/- for conduct of election.
