ORDER

Whereas, the East End Co-operative Group Housing Society Ltd. is registered vide registration No.524/GH dated 01.01.1974 with this department under the provisions of DCS Act & Rules framed thereunder;

Whereas, a Show Cause Notice under section 61 was issued on 04.03.2014 for submitting the reply within 15 days and also opportunity for personal hearing on 24.03.2014 at 03:30 P.M. was accorded to the President of East End Co-operative Group Housing Society Ltd. On the grounds of embezzlement /defalcation of public money qua the working and financial condition of the East End Co-operative Group Housing Society Ltd., Mayur Vihar-I, I.P. Extension, Delhi -110096.

Whereas, main issue raised by the complainant Dr. I.P. Gupta is that no NIT was issued/tender invited for the work worth more than Rs.35,00,000/- which was allotted to the four so called contractors handpicked by the then management and the selection of the contractors was pre-determined and pre-decided. The society in its reply dated 12.03.2014 has clearly stated that no NIT was advertised in the newspapers.

And whereas, Inspection under section 61 of DCS Act, 2003 has been completed as per Report of the Inspection Officer Sh. S.K. Hari (Retd. DRCS). The work has been awarded without observing codal formalities and procedures.

Now therefore, I Ashok Kumar Navet, Assistant Registrar (Section-II) hereby conveys the approval of Competent Authority to appoint Sh. Sanjay Gihar Spl. Director (Aayush), Tibia Hospital & College as Inquiry Officer under Section 62 of DCS Act, 2003. The Inquiry Officer shall fix the responsibility of person /office bearer of the society on the findings given by Sh. S.K. Hari. Quantum of lapses/misappropriation if any shall also be fixed. Further, the society shall pay Rs. 15,000/- (Rupees Fifteen Thousand Only) as remuneration to I.O. from the fund of the society for conducting the inquiry. The inquiry shall be completed within a period of 60 days of issue of this order.
