ORDER

Whereas, Swami Dayanand Coop. Group Housing Society Ltd., Plot No.05, Sector-06, Dwarka, New Delhi-110075 is registered with this Department vide Regn. No.1231/GH.

And whereas, all existing members of the Managing Committee has tendered their resignation and the President has conveyed the decision for dissolving the Managing Committee of the Society vide letter dated 14th September, 2015.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in her under DCS Act & Rules, appoints Sh. P. N. Mishra, DANICS (Retd.) as Administrator under section 35(5) of DCS Act, 2003, to manage the affairs of the society and conduct the election of the Managing Committee of the society within a period of Ninety days from the date of issue of the order and entitle to receive Rs.10,000/- (Rs. Ten Thousand Only) per months as honorarium out of the society funds.

Further, Sh. Sandeep, Supdt. (Education Deptt.) is also appointed by the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi as Returning Officer in the Swami Dayanand Coop. Group Housing Society Ltd., under section 35(1) of DCS Act, 2003 to conduct the election of the Managing Committee of the society and entitle to receive Rs.6,000/- (Rs. Six Thousand Only) as honorarium out of the society funds.
