ORDER

Whereas, Saral Coop. Group Housing Society Ltd., Plot No.15, Sector-10, Dwarka, New Delhi-110075 is registered with this Department vide Regn. No.662/GH.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoints Sh. P.K.Khanna Dy. Supdt. Group Housing Society Ltd., under section 35(1) of DCS Act, 2003 to conduct the election of the Managing Committee of the society and entitle to receive Rs.6,000/- (Rs. Six Thousand Only) as honorarium out of the society funds.
