With reference to your office letter no. PA/DRCS-I/2015-16/508 dated 05.08.2015, whereby a grievance application under CM public grievance monitoring system have been forwarded to this section. The main grievance of Dr. Anil Sharma is regarding non furnishing of information under section 139 of DCS Act 2003. The applicant Dr. Anil Sharma filled RTI application before the managing committee of the society to seek some information pertaining to the record of the society. Thereafter appeal before the undersigned under section 139(2) of DCS Act 2003 has been filed. After the hearing the matter in length undersigned pass order dated 01.05.2015 with direction to furnish the requisite information to the applicant.

The fact of the case are that the erstwhile managing committee of the society has not handed over the record to the new managing committee and even to administrator who is currently heading the society. In this regard this office in term of section 38 of DCS Act 2003 has requested vide letter dated 20.04.2015 and subsequent reminder 31.07.2015 to Divisional Commissioner, GNCT of Delhi to recoup the record from the erstwhile managing committee of society.

Further, chairman Public Grievance Commission GNCT of Delhi vide direction dated 06.08.2015 has also directed District Magistrate (South West) revenue department GNCT of Delhi to take note on the direction hence department as well as public grievance is trying to best to recoup the record from erstwhile managing committee of the society.
