Sub: Status Report in respect of grievances no. 2015-11682 and complaints dated 24.03.2015 made by Mr. Prakash Parewa, Ex.- President Air India Employees CGHS Ltd.

Sir,

This is with reference to your office letter dated 07.04.2015 on subject cited above, in this regard the status report is as under:-

- 1.) Operation of Bank Account:- Vide letter dt. 09.07.2014 Sh. Prakash Parewa, President of the society submitted that operation of the SB Account of the society has already been discussed in the GBM of the society held on 09.02.2014 and PNB has already requested in this regard. He further requested this office to issue a permission letter to the Bank at urgently.

In this regard it is submitted that the GBM of the society was held on 09.02.2014. Sh. Ashok Naved, AR(West) was deputed as observer on behalf of this office. In this report, the observer concluded that the said GBM was not as per DCS Act and Rules.

It may be pertinent to mention that the account of the society was freezed by the Punjab National Bank on the instructions issued by this office vide letter dated 22.01.2014 till a mutually agreed decision is taken by the GBM.

Vide letter dated 09.09.2014 the decision was reiterated and Bank agency was informed not to allow operation of Account of said society till a mutually agreed decision is taken by the GBM.

- 2.) Election:- The last election of the society was held on 15.04.2013. No regular managing committee was there as President/Secretary resigned in 2013. Adhoc committee set up. Most of the members of the Adhoc Committee have also resigned. To have a legally established managing committee vide order No. F.47/1378/Coop/GH/West/193 dated 06.03.2014 Sh. V.D. Diwan was appointed as Returning Officer to conduct election within 60 days.

Vide this office letter dated 21.11.2014 Sh. Prakash Parewa, President of the society was directed to cancel the GBM to be held on 23.11.2014 and to help the

Returning Officer to conduct the election of the society within 30 days from the receipt of this letter. In response, instead of conducting election, Sh. Prakash Parewa, President of society requested this office to fix the fresh date of GBM and raised other issues vide his letters dated 26.11.2014, 02.12.2014, 01.12.2014, 21.11.2014.

The Returning Officer Sh. V.D. Dewan vide his letter dated 27.11.2014 informed that till date he has not received any record from the society because the President Sh. Parakash Parewa has already stated that the records/documents of the society has not been handed over by the previous MC to him.

After examining the matter, this office vide order dated 19.02.2015 appointed Sh. Pankaj Kumar, Addl. Secretary (Home), Home Department, GNCT of Delhi as Administrator under section 35(5) of DCS Act 2003 to hold the election of the managing committee of the society.

- 1.) Verification of records/documents of members:- In this regard, the said matter was examined and found that the said society is a self-draw society. The regularisation process of the Government in respect of 26 self-draw societies has been stayed by the Hon'ble High Court of Delhi. The said court case is still sub-judice before the Hon'ble High Court. Further necessary action will be taken as per the directions of Hon'ble High Court in respect of regularisation process of self-draw societies. Same information has been already furnished to Sh. Prakash Parewa during Hon'ble CIC hearings.

This is for your kind information and further necessary action.
