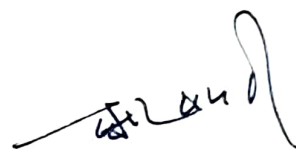

Sir,

In continuation of my earlier letters dated 7th and 21st August 2006, I wish to reiterate that the affairs of the *Sanchar Vihar Co-Op. G/H Society Ltd.* [Regd. No. 1323 (GH)] are being managed in a manner which is detrimental to the interests of the genuine members and also in violation of the provisions of the Delhi Co-operative Societies Act, 2003.

In this connection, I wish to point out that the Society had sent you on 14.10.2005 a List of Members containing 115 names for your approval for draw of lots for flats. This entire list cannot be approved since 65 members out of this list are defaulters. The list of 65 defaulters is enclosed here as Annexure - I for your kind information. The list of 50 members who have cleared their full dues to the Society is also enclosed here as Annexure - II. It is only these 50 members whose names can be approved for draw of lots.

Further, the following eleven members whose names have been forwarded to you for approval were not eligible to be the member of Sanchar Vihar Co-op. G/H Society Ltd. [Regd. No. 1323 (GH)] since they already own house/flat in Delhi either in their name or in the name of their spouse or dependent children:-

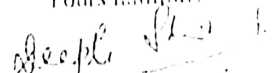

(b) direct further investigation into the truth of Affidavits of other members to find out whether any other member has similarly ceased to be a member under clause (b)(i) of Section 87 of the Delhi Co-operative Societies Act, 2003;

(c) direct investigation into the truth of the Affidavits and Verification Certificates submitted by the members to ascertain as to whether they are the residents of Delhi or not and whether they were eligible to be members of Sanchar Vihar Co-operative Group Housing Society Ltd. and in case any member had illegally acquired the membership of Sanchar Vihar Co-operative Group Housing Society Ltd. by submitting false Affidavit/Verification Certificate, the membership of such a person must be cancelled; and,

(d) file criminal complaint and prosecute all those who have acquired membership of Sanchar Vihar Co-operative Group Housing Society Ltd. illegally by submitting false Affidavits and Verification Certificates.

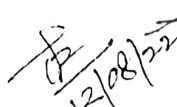
