ORDER

Whereas The Oriental Co-operative Group Housing Society Ltd., Plot No.32, Oriental Enclave, I.P. Extension (Patparganj), Delhi-110092 is registered with Registrar Cooperative Societies Department vide registration No.216 (G/H) under the provisions of DCS Act/Rules framed there and Bye Laws of the society.

Whereas complaints dated 13/06/15, 18/09/15 and 19/11/15, of Sh. V.P. Sharma and dated 18/09/15, of Sh. R.K. Sharma (MS No.58) to the effect that the Managing Committee has committed various irregularities contravening the provisions of DCS Act and Rules including financial irregularities.

Whereas in view of serious allegations made by Shri V.P. Sharma and Sh. R.K. Sharma, the comments of President/Secretary, The Oriental Co-operative Group Housing Society Ltd., Plot No.32, Oriental Enclave, I.P. Extension (Patparganj), Delhi-110092 were sought vide this office letters dated 04/08/15 and 08/12/15.

Whereas a reply dated 17/08/15 from the Hon. President/Secretary has been received and another reply dated 29/12/15 has been received by unauthenticated person signed 'for and on behalf of Managing Committee'.

And whereas Sh. Rajiv Khanna has tendered his resignation dated 26/11/15 from the post of President while making various allegations to the members of the Managing Committee vide letter dated 26/12/15.

Now therefore, Competent Authority has appointed Shri Ashok Kumar Navet, Assistant Registrar, Section-V, RCS office as an Inspecting Officer under section 61 of DCS Act, 2003 to inspect all the complaint / allegations including dated 13/06/15, 18/09/15, 19/11/15, of Sh. V.P. Sharma, dated 18/09/15 of Sh. R.K. Sharma (MS No.58) and dated 26/12/15 of Sh. Rajiv Khanna (MS No.114).

The Inspection report by Shri Ashok Kumar Navet shall be submitted to the Registrar, Co-operative Societies within two months from the date of receipt of this order and he shall be paid Rs.15,000/- (Rupees Fifteen thousand only) as consolidated remuneration from the funds of the society for conducting inspection.
