Arvind CGHS has registered in this department on 31.03.1973 vide Registration No. 158-GH having its registered office at 183, 1st Floor, Panchsheel Park, New Delhi – 110017. At the time of registration there were 52 promoter members. Freeze list of 114 members was sent to DDA on 03.01.2003 by this office.



This society is one of the 57 CBI investigated societies. The society was liquidated vide order no. 1993-99 dated 16.05.1979 (pl. see at page 66/C).



As per the findings of CBI charge-sheet, the Approval for liquidation and appointment of liquidator was given by the Ld. RCS on 03.03.2011. However the society filed writ petition WP (C) No. 1786/2011 which quashed the Liquidation order passed by the RCS and directing RCS for adjure revival of the Society. The order dated 23.05.2011 of the Hon'ble High Court is as under: -

"The petitioner society will move a requisite application for its formal dejure revival, since for all intents and purpose defacto the petitioner has been live and kicking. On an application being filed, the Registrar shall consider it keeping in mind the aforesaid facts and circumstances. Appropriate order shall be passed on the application within a maximum period of one month."



Subsequently, society filed an application for adjure revival of the Society. Since the above directions of the Hon'ble High Court was not implemented, The Society filed another WPC/2426/2011 titled Arvind CGHS Ltd V/s RCS & Ors. The Hon'ble High Court passed an order on 23.05.2001 which is as under: -

"The petitioner society is aggrieved by the non-forwarding of the list of 114 members by the Registrar Co-operative Societies (in short Registrar) to the DDA for holding draw of lots. The impediment in the way of the petitioner was the order passed on 03.03.2011 which was been quashed in WP(C) No. 1786/2011. The issue of formal revival of the petitioner society is required to be processed within a period of one month in terms of the directions passed therein.

On the relevant order being passed for revival, the names of the members of the petitioner society will be forwarded to the DDA within a week thereafter for the DDA to hold the draw of lots within 15 days of receipt of names.

The directions passed in WP(C) No. 2441/2011 today (following directions issued by this court in other matters) for furnishing affidavit(s) and undertaking(s) by the members of the petitioner society will also be followed in the present case as well."



The Department filed SLP case CC No. 18305-18306 /2011, titled RCS & Others V/s Arvind CGHS Ltd. came for hearing in Hon'ble Supreme Court on 05.12.11 and Hon'ble Supreme Court of India has dismissed the SLP.
