The C.B.I.P. Co-operative Group Housing Society Ltd. is registered in this department vide registration No.937-GH at registered Address: C.B.I.P. Building Malcha Marg, Chanakya Puri, New Delhi -110021, the Delhi Development Authority has allotted land in the premises of Plot No.8-B, Sector-7, Dwarka, New Delhi -110075. The freeze strength of the society is 52 out of which 50 members have already been cleared by this office in three phases i.e. 46 members were cleared in August, 2001, 03 members were cleared on 13.12.2001 and 01 membership was cleared on 13.05.2008. The case for clearance of membership of Sh. Swapan Das Gupta (Membership No.131) was detained at the time of main draw due to defaulter in payment toward land money and flat cost. Sh. Swapan Das Gupta was enrolled as the member of the said society on 23.07.1993.

Now, the society vide letter dated 21.09.2013 has submitted the proposal as per schedule-VII of DCS Rules, 2007 in r/o Sh. Swapan Das Gupta (Membership No.131). The documents regarding eligibility of membership in r/o Sh. Swapan Das Gupta has been checked as per Schedule-VII of DCS Rules, 2007 viz. Individual Affidavit (in the





form 'C'), Verification certificate (in the form of form 'F') from Gazetted Officer, No objection certificate from the managing committee of the society regarding dues toward land money and flat cost, Managing Committee resolution of the society, Application form for enrollment of the member, Counter file of Share Certificate has been submitted by the society and original record of the society has been checked and found in order.

As far as requirement of 03 years old residence proof on the date of application is concerned, Sh. Swapan Das Gupta (Membership No.131) was enrolled as member of said society on 23.07.1993. As per Notification No.F.47/legal/Policy/Coop./92/ 2305-2316 dated 05.12.2001 the members enrolled during the period 16.12.1992 to 22.04.1997 are exempted of having 03 years residence proof of Delhi prior to his/her enrolment.
