**NAME OF THE SOCIETY:- K.M CGHS LTD.**

01. The K.M. CGHS Ltd., Plot No.12, Sector-12, Dwarka, New Delhi-75 is registered with this Department at Sl. No. 1351/GH. The total existing freeze strength of the society is 98. Out of total 98 members the names of 97 members have been cleared for draw of lots from the O/o RCS.
02. It is pertinent to mention here that the proposed member Sh. Ravi Gupta, Membership No.313 was enrolled by the society on 05.01.2004 and society has itself allotted flat to him on 12.01.2004 without obtaining the approval from Office of Registrar Coop. Societies and DDA. However the claim of the member and the society is that there is only one single flat and Sh. Ravi Gupta is the only claimant and hence no draw of lots was required to be held.
03. The case was put up before RCS for regularization of membership of Sh. Ravi Gupta, M.S.No.313 in the light of the order No.F.47/276 /RCS/Coop./NW/GH/827 dated 20.09.2012 passed in the court of RCS in the matter of Smt.Annu Khurana member of Ganga Triveni CGHS Ltd. RCS has accorded prior approval to place the case before Rule-90 Committee meeting for approval for regularization of membership of the above mentioned member.
