## RULE 90 MEETING REGARDING LORDS CGHS LTD. (SOUTH ZONE)

AGENDA FOR THE MEETING OF THE COMMITTEE CONSTITUTED UNDER RULE 90 OF THE DCS RULES, 2007 TO BE HELD ON 28.01.2013 AT 3.00 P.M. UNDER THE CHAIRMANSHIP OF THE SECRETARY (CORPORATION)/REGISTRAR COOPERTIVE SOCIETIES.

Lords CGHS has registered in this department on 22.09.1983 vide Registration No. 615-GH having its registered office at 1668/1, Govindpuri Extn., New Delhi. At the time of registration there were 75 founder members. Freeze list of 70 members was sent to DDA on 04.09.1989 by this office.

This society is one of the 57 CBI investigated societies. The society was under liquidation on 28.09.1989 as it failed to submit the requisite documents in the office of RCS. The society remained liquidated till 2002 and the then RCS revived the society on 24.12.2002. After revival the list of 115 members as freeze list was forwarded to DDA.

Again the approval for liquidation and appointment of liquidator was given by the Ld. RCS on 06.04.2011. However, the Society filed writ petition vide WP(C) No. 2441/2011 and CM No. 5219/2011 titled Lords CGHS Ltd V/s RCS & ors. The Hon'ble High Court passed an order on 23.05.2011 stating therein:-

"we direct that on such an affidavit being filed, the list of members submitted by the petitioner/Society be processed in accordance with law and be forwarded to the DDA within a period of one month thereafter and the DDA shall hold a draw of lots within a period of 15 days thereafter.

We would like to clarify that for a proper adjudication in proceedings which may be initiated by promotee/member(s), not only entitlement of such members has to be examined, but also as to whether such members ever contributed to construction of flat(s) of the Petitioner/Society and whether they had shown continued vigilance towards their entitlement at the relevant stage.

The writ petition is allowed in the aforesaid terms. The petition and the application stand disposed of".

The petitioner society filed a CM No 19686/2011 in WP(C) 2441/2011, titled Lords Coop. Group Housing Society Ltd. V/s A.B. Shukla & Ors. came for hearing in Hon'ble High Court on 21.12.2011, directing therein: -

"we have no doubt that the Registrar Cooperative Societies is in breach of the order dated 23.05.2011.

Learned counsel for respondent No 1/RCS states that as a last opportunity two weeks time be granted to comply with the order but subject to the Special Leave petition.

We are inclined to accede to the request but see no reason why the petitioner should not be compensated with costs for being compelled to approach this court again by filing the present application. We thus grant two weeks further time to respondent No 1 to comply with the directions contained in the order dated 23.05.2011 and impose costs of Rs.7500/- on respondent No 1 to be paid to the petitioner within the same period of time.
