ORDER

This order shall dispose of the appeal filed by Sh. Nand Lal, in respect of his application vide ID No. 198 dt. 17.02.2016, u/s 19 of the Right to Information Act, 2005. Sh. Nand Lal was present, the appellant was present on 17.05.2016. None was present on behalf of the PIO/AR(Housing).

The appellant in his above RTI application sought following information:-

1. Copy of the list of original allottees of Hanuman Mangla Coop. Group Housing Society (487E-GH) alongwith Membership No., members Name, Father's Name, Address, Admission Share, Date of Allotment.
2. Date of order and copy of order of Registrar of Coop Societies with which the Hanuman Mangla Coop. Group Housing Society(487E-GH) was superseded.
3. Copy of the list of members of Hanuman Mangla Coop. Group Housing Society(487E-GH) as of end of 2013 alongwith membership No., Members Name, Father's Name, Address, Date of Application seeking membership, Admission Share, Date of approval of membership by M/C.

He did not receive any reply/information from the PIO/AR (Sec-3). Neither the PIO/AR Sec-3 issued any notice under section 11 of the right to information Act, 2005 to the Society inviting its submission, if any, regarding whether the information should be disclosed. The AR (Housing) is now directed to provide the information No. 1 & 3 in the form available in the records of the Section-3. A copy of order of RCS with which the M.C. of Hanuman Mangla CGHS Ltd., superseded (if presently under the charge of Administrator) also be furnished. All the above information will be provided free of cost within 3 weeks of receipt of this order.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
