ORDER

This order shall dispose of the appeal filed by Sh. Dharam Pal, in respect of his application vide ID No. 1421 dt. 10.11.2015, u/s 19 of the Right to Information Act, 2005. Sh. Dharam Pal, the appellant was present on 29.12.2015. None present for the PIO/AR (Sec.-7).

The appellant in his above RTI application sought information/documents in respect of 6 Arbitration cases filed during 2009-10 between the Saya Cooperative Credit and thrift Society, Sector-9, Rohini *Versus* (i) Tej Pal, (ii) Sunil, (iii) Sanjeet, (iv) Vikas, (v) Raj Kumar and (vi) Sushila. The information required in above arbitration cases include inter alia certified copy of Bond Form in respect of the borrower submitted by the Society; certified copy of loan application form; certified copy of A/c statements of defaulters members submitted by the Society; certified copies of order u/s 70 issued by AR (Arb.) and certified copies of Award u/s 71 of DCS Act issued by Arbitrator.

The appellant received a reply dt. 30.11.15 from the PIO/AR (Audit) informing against each information that it does not pertain to Audit Branch. The PIO/AR (Audit) should have either sent the above RTI application to the PIO/AR (Sec.-7) with whom the information is available or preferably should have obtained information from the concerned PIO within the same Public Authority.

The information sought by the appellant has been carefully perused. In my opinion all the information sought pertain to third parties. The appellant could not claim public interest in his being made privy to an information which was all about a dispute between the Society and six altogether different persons. In consideration of the above, the appeal is disallowed.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
