ORDER

This order shall dispose of the appeal filed by Sh. D.K. Garg (M.No. 398) against the President/Secretary of the Agarsen Cooperative Group Housing Society Ltd., Patparganj, Delhi-92 for not providing information on his RTI application under section 139 of DCS Act 2003, Sh. D.K. Garg, the appellant and Sh. Durgesh Kumar, the manager of the defendant society were present on 24.11.2015.

The appellant in his above RTI application sought certified copies of register of properties of Agarsen CGHS Ltd. maintained in Form No. 24 under Rule 103 of DCS Rules from the year 1980 to 07.06.15. The appellant did not receive any information from the society.

The appellant being a member of the Society is entitled to get the said register of properties which contains the details of land, building, common areas & services etc. During the hearing the Society was accordingly directed to provide the asked information after charging prescribed fee from the appellant. The prescribed fee meant for the documents pertaining to the certified copies of register of properties. It has been informed by the Society that the appellant did not remit the fee of Rs. 10/- along with his initial application letter dt. 07.06.2015.

The application dt. 07.06.2015 seeking information under section 139 & Rule 165 of DCS Act & Rules was sent to the Society through speed post. As per detailed track events for ED652234807IN enclosed by the appellant, application is shown delivered on 09.06.15. The society has not denied having not received the application. The RTI application is however, silent about the deposit of fee for seeking information. The application without fee is not maintainable under the provision of sec. 139 r/w Rule 165 of the DCS Act/ Rules.

The Society is, however, directed to provide information as sought above within the time specified u/s 139 (1) of DCS Act 2003 after receiving prescribed fee against the said RTI application.

The appeal is disposed of accordingly with the above observations.
