ORDER

This order shall dispose of the appeal dated 21.04.2016 of Sh. Nirmal Kumar Bolia r/o C-601, Lovely Home CGHS Ltd, Dwarka filed under section 19 of RTI Act, 2005 ID No- 304 dated 09.03.2016 against un-responded/pending RTI application with PIO/AR(Sec-4). This appeal was received from DRCS-III on 19.05.2016 on restructuring of office setup of this Department vide order dated 13.05.2016.

The appellant in person was present on 17.05.2016. None present on behalf of PIO/AR(Housing-1).

The appellant in his above RTI application sought copy of file No. F107292468/RCS/Section-IV pertaining to order No. F107292468/RCS/Section-IV/241-242 dated 25.02.2016 u/s 61 of DCS Act 2003 appointing Sh. P.C Jain, Spl. Secy GAD as Inquiry Officer in the matter of Lovely Home CGHS Ltd (Regn No-1354) and also the term and reference of the said inquiry. The appellant handed over the copy of reply dated 27.04.2016 of the PIO/AR(Section-IV) alongwith order dated 25.02.2016 of the appointment of Sh. P.C Jain, Spl. Secy, GAD as Inquiry Officer U/s 61 of the Act during the hearing on 17.05.2016. Vide his reply dated 27.04.2016, the PIO/AR(section-IV) informed the appellant that the requisite documents may be obtained by depositing Rs. 2 per page. Further, it was requested to inspect the file at any working day except Wednesday.

There is no deficiency in the reply of the PIO/AR(Section-IV) except that it was given after stipulated period of 30 days. The PIO/AR(Housing-1) is directed to facilitate inspection of the said file to the appellant. The appellant may inspect the file within 30 days of receipt of this order and get the requisite documents free of cost.
