**ORDER**

This order shall dispose of the appeal filed by Mr. A.P. Sharma, in respect of his RTI application dated 19.05.2015 ID No. 563 u/s 19 of the Right to Information Act, 2005. Mr. A.P. Sharma The appellant was not present on 20.07.2015. Another notice was issued to the appellant for hearing on 14.08.15 but again he did not attend the hearing . Nor did the PIO/AR(Sec.7) was present. In response to the later notice, however, this office is in receipt of a letter dt. 27.08.15 from the appellant informing therein that he received incomplete and misleading information vide letter dt. 13.7.15 of PIO/AR (Sec.7).

The appellant sought information about (i) the status/action taken on his representation forwarded by the Addl. Secretary to LG vide letter dt. 29.02.12 to the office of RCS and (ii) the penalty, if any, imposed on the President of Shruti Apartment, Dwarka under Section 139 of DCS Act following letter no. F.47/GH/ 1145/ SW/Coop/734 dt. 12.06.12 to the President/Secretary of the Society. The PIO/AR (Sec.7) vide his letter dt. 13.07.15 informed the appellant that the matter (i) pertains to the Audit Branch, and with regard to (ii), the appellant was requested to inspect the concerned file/record. The reply of the PIO/AR (Sec.7) is not as per the spirit of the RTI Act, he should have either referred the RTI application to the Audit Branch/Vigilance Branch within the prescribed period or had collected the requisite information from the concerned Audit/Vigilance Branches for providing to the appellant.

Now the said RTI application is forwarded to the Audit Branch and Vigilance Branch for providing the information pertaining to them within a period of 3 weeks from receipt of this order. PIO/AR (Sec.7) is directed to furnish the information with regard to information (ii) above within a period of 2 weeks from receipt of this order.

The appeal is disposed of accordingly with the above observations.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
