ORDER

This order shall dispose of the appeals filed by Mr. Sunil Kumar Kedia, in respect of his 55 RTI applications vide ID No. 688-700 dt. 11.06.15, 721-736, 740-745 dated 16.06.2015, 797-801 dt. 24.06.15, 850-853, 860-865 and 878-882 dt. 29.06.15 u/s 19 of the Right to Information Act, 2005 against the response of PIO/AR (Sec.-6) Mr. R.S. Kedia, the father of the appellant and Sh. Pritam Singh, Inspector on behalf of the PIO/AR (Sec.-6) were present on 14.09.2015.

The main contention of the appellant is that as per the provisions of the DCS Act 1972, Rules, Bye-Laws framed there under, the person acquires the rights of membership when his admission fee and share money has been accepted by the society, which stands received and accepted by the Prem Kutir CGHS Ltd. on 24.03.1990 by cheque under their receipt no. 17/90-91 dated 10.04.1990 and resolution dated 09.09.1990. The crux of the information sought by him in his almost all 55 RTI applications is about the present status of his above said entitlement as a bonafide-cum-eligible member of the society and entitled for a flat. He also sought steps/ actions taken on his various complains to the deptt. and received in the deptt. from other agencies/ offices. The said letter-cum-communications/ complaints, to mention some of these, are dated 12.04.93, 15.05.94, 02.07.94, 08.06.94, 28.06.95, 01.04.95, 22.03.95, 17.05.95, 21.10.95, 21.11.95, 28.07.95, 18.09.95, 18.12.95, 08.12.95, 27.09.95, 18.01.96, 31.03.97, & 02.04.99.

The PIO/AR (Sec.-6) vide his reply dt. 09.07.15 (ID No. 688-700), 15.07.15 (ID No. 721-736) (ID No. 740-745), 24.07.15 (ID No. 797-801), (ID No. 850-853), (ID No.860-865), 30.07.15 (ID No. 878-882) informed the appellant that the sought information is not covered under section 2 (f) of the RTI Act. On his RTI applications in ID No. 741 & 742, the appellant was advised to inspect the file and obtain the copy of the document @Rs. 2 per page.

During the hearing the appellant filed "*a comprehensive report of the Society named Prem Kutir Co-operative Group Housing Society Ltd., Regd. No. 338/GH, Plot no. 25/1, Sector-9, Rohini, Delhi-110085 in respect of unresolved cases including...*" holding him a bonafide cum eligible member of the Society and entitled for a flat. The representative of the PIO/AR (Sec.-6) held that the appellant is aggrieved against the Society on the issue of

his membership for which he has abruptly started filing RTI applications one by one totalling 55 asking therein action taken report on his various letters dated mostly as long as back to the years 1993 onwards. It was further submitted that the information sought was not only voluminous but also on the issues that pertained to 1990s, the collation of which would disproportionately divert their limited resources.

The appellant has filed 55 different appeals against the replies of the PIO/ AR (Sec.-6) stating that the sought for information has been wrongly decided. The appellant, while seeking information about action taken on various communications which date back to 1990s, has not indicated the bonafide public interest in seeking the same. It would have been better had he minimized and prioritized his information needs which could be provided without unduly jeopardizing the normal functioning of the office, as the information is to be provided within the stipulated period of 30 days. The appellant may, therefore, inspect for himself whichever file of the Prem Kutir CGHS Ltd. he wants information on within a period of 30 days of receipt of this order.

The appeal is disposed of accordingly with the above observations.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
