## **ORDER**

This order shall dispose of appeal dt. 29.06.15 of Ms. Geeta Narula aginst the response of the PIO/AR (Sec.-5) on her RTI application filed under RTI Act 2005. The appellant was represented by her counsels Sh. R.C. Beri and Sh. Suresh K. Beri. Sh. B.K. Puri, the PIO/AR (Sec.-5) was present during the hearings.

The appellant in her RTI application vide ID No. 393 dt. 17.04.2015 sought information regarding her application dated 28.06.2011 filed before Asstt. Registrar Coop. Societies (East) u/s 139 (2) DCS Act 2003 r/w Rule 165 (8) of DCS Rules, 2007 for imposing penalty for default in complying with order dt. 03.03.2011 passed in appeal no. 139/DCS/AST/325 titled as Smt. Geeta Narula vs. Sh. P.C. Jain, Administrator of the NDSE CGHS Ltd., Vasundhara Enclave. The PIO/AR (Sec.-5) vide his letter dt. 25.05.2015 replied that the said appeal u/s 139 is about four years old and must have been submitted in the erstwhile east Zone. Moreover in June, 2014, these erstwhile zone were disbanded and new sections were created in their place. Nevertheless, a thorough search of this section was made but the said records could not be traced.

It is therefore, requested to kindly provide the copies of said applications under section 139 in order to enable this office to process the matter expeditiously.

Not providing the information because of the reason records are not traceable in the concerned section is deplorable. Further requiring said RTI application/appeals from the appellant at this stage after lapse of more than 3 years is unwarranted as it may cause legal repercussions of limitation etc. from the respondent society. Probably for this reason the appellant did not provide documents as requested by the PIO/AR (Sec.5) in his reply dt. 25.5.15 and rather the appellant preferred appeals against the said reply. The PIO/AR (Sec.5) is, therefore, directed to make concerted efforts to locate the requisite documents at both places i.e old zone and new section and provide the information asked for by the appellant within a period of 15 days from the date of receipt of this order free of cost.

The appeals are disposed of accordingly with the above observations.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before 5econd Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
