This order shall dispose of the appeal filed by Shri Anil Chadha, Appellant, in respect of his application dated 20.04.15, ID No. 222 U/s 19 of the Right to Information Act, 2005. Shri Anil Chadha, Appellant was present during the hearing on 19.05.2015.

The appellant in his appeal has requested to help him getting the requisite information and thereby protecting his right under RTI Act, 2005 and also requested to punish the PIO, Shri Narender Passi for furnishing incorrect and misleading information.

The appellant in his RTI application ID No. 222 dated 03.03.15 has sought following information in the light of declaration of MC Meeting dated 12.01.14 as unconstitutional by the RCS vide letter No. Misc/RTI/west/437-38 dated 09.06.14 and 19.02.15.

"Kindly inform whether these unconstitutional Acts, declared unconstitutional (Convicted) by the RCS, of the seven members of the committee namely Sh. D.S. Thakur, Sh. Ashok Kumar Sharma, Sh. S.S. Pathania, Sh. Pyar Chand, Sh. Surender Kumar Vidhyarthi, Sh. Surender Sharma and Smt. Tripta and the unlawful operation of the bank accounts of the society by Sh. D.S. Thakur and Shri Ashok Kumar Sharma since 25.01.14, which are Acts of moral turpitude and dishonesty both as per definition provided above, are also acts of dishonesty and or of moral turpitude in terms of the provisions of Rules 54(D) and 55(E) of DCS rules 2007 or not".

The PIO (Section-IV) is hereby directed to give the requisite information as the Managing Committee meeting dated 18.01.14 of the Kangra Adarsh CGHS Ltd. had been declared unconstitutional by the RCS vide letter No. Misc./RTI/Sec-IV/59 dated 20.01.15 and meeting dated 18.01.15 declare unconstitutional by the RCS on 19.02.15, within two weeks of issue of this order. The appeal is disposed off accordingly.

As per Section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellant Authority i.e. Central Information Commission, August Kranti Bhawan, Bhikaji Kama Place, New Delhi.
