The society on 26.05.2016 furnished copy of reply dt. 10.12.2015 to Dy. Director (Bldg.) L&I/ PIO DDA in response to DDA notice dt. 10.11.2015 u/s 11 of RTI Act 2005 regarding consent for providing third party information. Copy of the above notice as well reply were provided to the appellant during the hearing. The reply dt. 10.12.2015 of the society to DDA may be taken as the reply to question No. 1 of the RTI application.

I have gone through the material on record and pleading of the parties. The reply of the society is now deficient with regard to information No. 2. The reply is apparently incorrect as the audit for the period 2012-13 cannot logically be done on 09.03.2013. Penalty, if any, for delay in audit has also not been intimated. The President/ Secy. Of the Sant Tulsi Dass CGHS, Rohini is directed to provide correct & complete information in respect of information No. 2 to the appellant within a period of 10 days of receipt of this order.
